Cambridge is an introducing firm and does not perform any type of clearing function for itself or others. Furthermore, it does not hold client funds or securities. It does, however, accept and enter orders. All transactions are sent to its clearing firms, which exclude orders, compare them, allocate them, clear and settle them. Its clearing firm also maintains customer accounts, grant client access to them, and deliver funds and securities. Cambridge's clearing firm is Pershing LLC

Pershing maintains records of customers funds or securities on our behalf. In the event of an internal or external disruption or event, if telephone service is available, registered persons will take customer orders or instructions and contact Cambridge on their behalf. If internet access is available the branch will post on the website that customers may access their funds and securities by contacting Cambridge at 800-777-8060

Securities regulations are designed to protect clients' funds and securities. The SEC is an agency of the U.S. government which oversees FINRA which in turn oversees Broker Dealers , clearing firms, and financial professionals. Both the SEC and FINRA require member to comply with various rules intended to minimize the chance of financial failure and maximize the protection of assets. The SEC also requires a registered broker-dealer to segregate fully paid for, investor owned assets – meaning that if the broker-dealer fails, investors' assets will remain safe, separate from the broker-dealer assets.
